Amendment - [Energy Performance of Buildings \(England and Wales\) \(Amendment\) \(No. 2\) Regulations SI 2016/888](#) - This amends the Energy Performance of Buildings (England and Wales) Regulations SI 2012/3118 to enable the disclosure of data from the Energy Performance Certificate Register for purposes related to Government policy to promote building energy efficiency.

[Finance Act 2016](#) - This act outlines various tax rates for the next financial year (starting 1st April 2017) including landfill tax and the climate change levy.

Consultation - [Consultation on the Implementation of Clean Air Zones in England](#) - This consultation runs from 13 October 2016 until 9 December 2016 and seeks draft Clean Air Zone Framework, which sets out how Clean Air Zones should be implemented, and on the draft Regulations mandating the implementation of Clean Air Zones in the five cities along with the associated impact assessment.

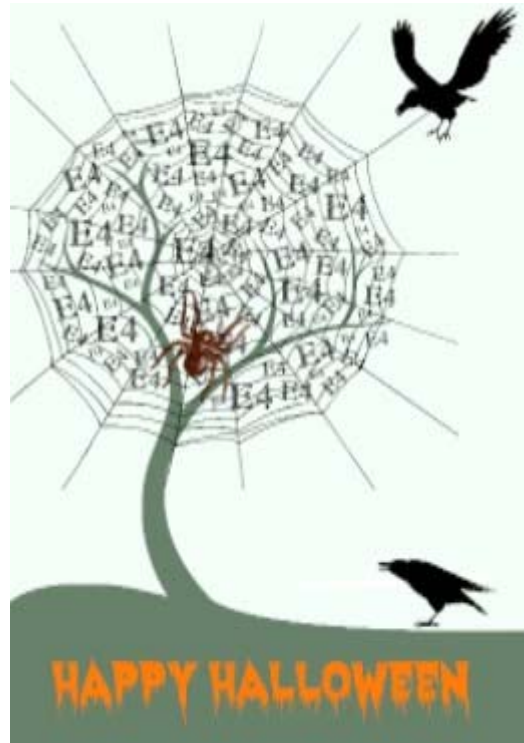
